

**Assumption and Acknowledgment of Risks
AND
Release of Liability Agreement
Breaking of Bread / (HOUSEHOLD WAIVER)**

This agreement releases **FEMALE SCRIBE OF GOD, LLC and TINA MARY MARTIN** from all liability relating to injuries that may occur while **BREAKING OF BREAD / COMMUNION**.

By signing this agreement, **(WE)** agree to hold **FEMALE SCRIBE OF GOD, LLC and TINA MARY MARTIN** entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence.

(WE) also acknowledge the risks involved in **BREAKING OF BREAD / COMMUNION**.

These include but are not limited to **Female Scribe of God not being held responsible for the physical/natural or spiritual consequences (i.e. APPEARANCE OF ANGELS, ATMOSPHERE CHANGE, MASSIVE HEALING, INDIVIDUAL HEALING, MASSIVE DEATHS, INDIVIDUAL DEATHS, ETC) of what may happen which is an act of God and nothing that she has any control over, and that she is to be immune to any lawsuits related to whatever may occur as a result of an individual's heart issues and the spirit that controls the church/organization/ household in question including the possibility of death.** **(WE)** swear that **(WE)** are participating voluntarily, and that all risks have been made clear to me.

By signing below, **(WE)** forfeit all right to bring a suit against **FEMALE SCRIBE OF GOD, LLC and TINA MARY MARTIN** for any reason. In return, **(WE)** will **partake in communion/breaking of bread.** **(WE)** move forward with full understanding of the "steps" / "manner" in which things will take place.

*** The following wording are the "steps" that will be taken by **TINA MARY MARTIN**

1. Upon my arrival to the Invitee's selected location, I will set my luggage outside the vehicle, retrieve ONLY the Communion necessities from my luggage, and I will follow the invitees inside the location. If I should have my own vehicle / car rental... all luggage will remain inside the vehicle.
2. Due to possible flight delays/schedule changes, the Invitees are to be prepared and willing to be obedient to the order. (For example, if my arrival is scheduled at 3 pm and it is changed/delayed to 11 pm, the Invitee needs to be prepared and available to participate In Breaking Bread upon the new arrival time. (NO EXCEPTIONS) The Invitee will provide the grape flavor juice (I will provide the wafer), once everyone is settled at the entrance of the location.
3. If you be in the location that I'm Invited to, you are EXPECTED to take part in the breaking of bread.
4. Please have children orderly and respectful. I will break bread with the children (who are able) first, and then adults after.
5. WARNING: The Invitee is to be prepared for anything in the will of Almighty God upon the Breaking of Bread and the time thereafter.

As a reminder the wording from **GOD ALMIGHTY, CREATOR OF ALL THINGS, HE THAT BROUGHT FORTH THE EARTH, HE THAT BROUGH FORTH A SON BY THE WOMB OF A VIRGIN WHO WALKED THE LAND WITH MANKIND, WAS CRUCIFIED, PLACED IN A TOMB, WENT TO HELL, PREACHED THE GOSPLE, WAS RAISED FROM THE DEAD AND NOW REIGNS AS KING IN THE KINGDOM OF GOD** has been made available to me.
