

**Assumption and Acknowledgment of Risks
AND
Release of Liability Agreement
(Individual(s) Water Baptism)**

It is understood and agreed that this Agreement is made and received in full and complete understanding, settlement, and satisfaction of the causes of action, claims and demands mentioned herein; that this Release contains the entire Agreement between the parties; and that the terms of this Agreement are contractual and not merely a recital. Furthermore, this Release shall be binding upon the undersigned, and his respective heirs, executors, administrators, personal representatives, successors and assigns.
