

**Assumption and Acknowledgment of Risks
AND
Release of Liability Agreement
(INFANT / Water Baptism)**

This agreement releases **FEMALE SCRIBE OF GOD, LLC and TINA MARY MARTIN** from all liability relating to injuries that may occur with WATER BAPTISM / BAPTISM BY WATER of an INFANT.

By signing this agreement, I / (WE) agree to hold **FEMALE SCRIBE OF GOD, LLC and TINA MARY MARTIN** entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence.

I, _____ also acknowledge the risks involved in WATER BAPTISM / BAPTISM BY WATER. These include but are not limited to **Female Scribe of God not being held responsible for the physical/natural or spiritual consequences (i.e. WATER IN NOSE / MOUTH, CHOKING, ANXIETY / HEART RATE INCREASE, CRYING, DIZZINESS, BLURRED VISION, MASSIVE HEALING, INDIVIDUAL HEALING, MASSIVE DEATHS, INDIVIDUAL DEATHS, ETC)** of what may happen which is an act of God or bodily functions and nothing that she has any control over, and that she is to be immune to any lawsuits related to whatever may occur as a result of WATER BAPTISM.

The parent / legal guardian of THE INFANT (MUST) have the absolute understanding that: the INFANT CHILD will be (submerged) / placed INSIDE THE BODY OF WATER provided for said WATER BAPTISM / BAPTISM BY WATER.

As the INFANT CHILD is in the possession / in the arms / in the hands of TINA MARY MARTIN and FEMALE SCRIBE OF GOD, LLC. The INFANT CHILD WILL BE PLACED / PUT (DOWN) INTO the water provided for the baptism (for a matter of seconds).

A cloth will be place (over) the infant's eyes, nose and mouth and the "act of water baptism / baptism by water" will immediately follow. At the completion of the BAPTISM BY WATER, the INFANT CHILD will be returned to the parent / legal guardian of the INFANT CHILD.

If the parent / legal guardian is not pleased / comfortable with the "body of water" chosen to baptize the infant, and that parent / legal guardian OPT NOT TO HAVE THE INFANT BAPTISED (at that time), FEMALE SCRIBE OF GOD, LLC. and TINA MARY MARTIN is NOT OBLIGATED to accommodate the parent / legal guardian now or in the near / far future, with WATER BAPTISM unto the infant.

THEREFORE under the terms of this Agreement and sufficiency of which is hereby acknowledged, do hereby release and forever discharge **FEMALE SCRIBE OF GOD, LLC and TINA MARY MARTIN**, of P.O. BOX 2188, City of **MARRERO**, State of **LOUISIANA** (Hereinafter the "Releasee") including their agents, employees, successors and assigns, and their respective heirs, personal representatives, affiliates, successors and assigns, and any and all persons, firms or corporations liable or who might be claimed to be liable, whether or not herein named, none of whom admit any liability to the undersigned, but all expressly denying liability, from any and all claims, demands, damages, actions, causes of action or suits of any kind or nature whatsoever, which I now have or may hereafter have, arising out of or in any way relating to any and all injuries and damages of any and every kind, to both person and property, spiritual and natural, physical and mental, and also any and all injuries and damages that may develop in the future, as a result of or in any way relating to the following:

BAPTISM BY WATER / WATER BAPTISM.

It is understood and agreed that this Agreement is made and received in full and complete understanding, settlement, and satisfaction of the causes of action, claims and demands mentioned herein; that this Release contains the entire Agreement between the parties; and that the terms of this Agreement are contractual and not merely a recital. Furthermore, this Release shall be binding upon the undersigned, and his respective heirs, executors, administrators, personal representatives, successors and assigns. This Release shall be subject to and governed by the laws of the State of _____,
